Talga attains ISO 14001 Environmental Accreditation

Battery and advanced materials company Talga Group Ltd ("**Talga**" or "**the Company**")(**TLG:ASX**) is pleased to advise it has been awarded the globally recognised ISO 14001:2015 certification for the Company's environmental management systems at the Electric Vehicle Anode plant, including onsite battery laboratories, and office in Luleå, northern Sweden.

In the delivery of battery and advanced materials it is imperative that products are manufactured with stringent environmental and social controls. To this end, Talga has developed an Environmental and Social Management System ("ESMS") to ensure high standards are continually met.

The ESMS covers safe use, management and transport of chemicals, waste and dust; safety procedures for emergencies; ongoing monitoring and auditing; and commitment and active support from leadership.

The ISO 14001:2015 certification, awarded by Europe's leading inspection verification company BSI, is an independent, third-party assurance of Talga's ESMS and forms part of a broader quality assurance program being implemented across Talga's operations in preparation for commercial battery anode and graphene additive production.

The certification follows the awarding of ISO 9001:2015 certification in July 2021 (ASX:TLG 29 July 2021) for the Company's strong quality management system ("QMS") which supports current pilot production, and progress through customer qualification processes into commercial manufacturing.

The Company also received approval in Q4 2019 from the European Chemicals Agency (ECHA), under the European Union's Registration, Evaluation, Authorisation and Restriction of Chemicals ("REACH") regulations, for commercial graphene manufacturing (ASX:TLG 31 January 2020).
