
Cleansing Notice - Issue of Shares as a result of Niska development land acquisition

Battery and advanced materials company Talga Group Ltd ("Talga" or "the Company") (ASX:TLG) advises of the issue of 270,000 fully paid ordinary shares pursuant to the Company's 15% placement capacity under ASX Listing Rule 7.1.

The shares were issued as part of a private land access and acquisition agreement relating to development of the Vittangi Graphite Project in Sweden, with particular focus on the planned Niska expansion.
